

# Privacy Policy

## Article 1. (Establishment of Organization for Personal Information Protection)

1. Amaneks LLC (hereinafter referred to as "the Company") is fully aware of its social mission regarding the protection of information capable of identifying Users individual that the Company handles (hereinafter referred to as "personal information"), and complies with laws and regulations regarding personal information in order to protect the rights of the Users.

## Article 2. (Usage Purpose of Personal Information)

1. The Company does not use Users' personal information beyond the scope of the following usage purposes without any consent from the Users.
  - (1) To provide and operate the Service;
  - (2) To improve and maintain the Service;
  - (3) To respond inquiries from Users;
  - (4) To monitor traffic and behavior of Users;
  - (5) To respond based on the provisions of laws and regulations or the notifications and guidance from administrative authorities;
  - (6) If the Company specified any other purpose of use at the time of acquisition of the personal information, to achieve the purposes.

## Article 3. (Handling of Personal Information)

1. When Users access the Service, the Company may acquire log data and other information decided to acquire via the App from the Users. This log data may include Internet Protocol (IP) address of the device, device name, operating system version, app configuration at the time of using the Service, date and time that the service was used, and other statistics.

## Article 4. (Module for Information Collection)

1. About the items of information acquired by the information collection module, the purpose of use, and whether or not the information is provided to a third party, please check the privacy policy of the following services.

Google Analytics is used in the App to understand the usage status of Users. The collection of information of Users is managed in accordance with privacy policy of Google.

Article 5. (Safety Management Measures of Personal Information)

1. The Company takes appropriate organizational, physical and technical safety management measures for prevention of unauthorized access to personal information and loss, destruction, falsification, leakage, etc. of personal information and for other safety management of personal information.

Article 6. (Provision of Personal Information to Third Party)

1. In the case of occurrence of urgent needs to protect human life and human rights, in the case of cooperating with a request based on laws and regulations by a public institution such as judiciary or police, or in the case of complying with other laws and regulations, the Company may disclose the personal information of Users without any notice.

Article 7. (Amendment of Privacy Policy)

1. The Company may review the handling method of personal information as appropriate and amend this privacy policy. However, if any procedures required for revision are stipulated in laws or regulations relevant to handling of the personal information such as Act on the Protection of Personal Information and other laws and regulations, the revision shall be made based on the relevant laws or regulations.

Article 8. (Suspension of Use of Personal Information)

1. If suspension or deletion of personal information (hereinafter referred to as "Suspension of Use, etc.") is requested from Users because the personal information is handled beyond the scope of the purpose of use or because the personal information was obtained by unauthorized means, the Company shall perform the necessary investigation with no delay.
2. If the Company determines that responding to the request should be necessary based on the survey results in the preceding paragraph, the Company perform suspension of use, etc. of the personal information with no delay.
3. When the suspension of use, etc. is performed based on the provisions of the preceding paragraph or when the Company determine not to perform the suspension of use, etc., the Company will notify the Users of this with no delay.
4. When the suspension of use, etc. is performed based on the provisions of the preceding paragraph or when the Company determine not to perform the suspension of use, etc., the Company will notify the Users accordingly with no delay.
